Subject: Applications for Board of Directors and Executive Officers Elections

The time for general elections has come again and this is the memberships' notice for those who wish to be considered for election to an office. In order to be considered by the nominating committee, there are a few common-sense requirements that all applicants need to be in compliance with:

1. Be a member in "good standing". This means in total compliance with the Bylaws, Rules, Regulations, and Covenants and a promise to remain in that status throughout the entire length of your term, should you be elected.
2. Return your application by April 30, 2020 to the mailing address: 4922 Puget Rd NE, Olympia, WA 98516-9211. You are responsible for your own envelope and stamp. **All envelopes containing an application must be have a return name and address on them – no exceptions. This procedure was implemented to ensure that there will be no lost applications. Please make sure you put on the envelope "in care of The Nomination Committee"**. The Club must have your current phone number and email, so that the nominating committee can call and set up an interview with you. The applications will be kept unopened and turned over to the interviewing committee for review. There **must not** be anything else in the envelope such as payments to the Club, otherwise they may get posted late and incur late charges. Application will only be accepted from members in "Good Standing".
3. The rule of no campaigning will be observed. This applies to both the positive and negative. Your opportunity to state all of your qualifications is to be listed in the application. If there is insufficient room to list all your qualifications, please feel free to add a page of your own.

These positions can be considered a part time to full time job. The Board of Directors applicants must be tech savvy and be able to respond in a timely manner to emails. Email issues are dealt with on a regular basis. Board members are on call 24/7 for emergencies.
